All applications which are submitted on time will be considered at the same time, after the closing date.

You will be advised the outcome of your application on \$6\text{April 2024}, or the next working day, by the local authority on behalf of the school.

Please note that throughout this policy, the term parent means all natural parents, any person who is not a parent but hasparental responsibility for a child and any person who has care of a child.

For the purposes of this policy, a looked after child living with a family where at least one of the carers is Catholic will be considered. Catholic. The carer must forward a copy of their own Catholic Baptismal or Reception certificate directly to the school in order for this priority to be given to the child as failure to do so will result in the looked after child being ranked as a-Catholic.

If the request is refused, the original application for the normal age group class will progress through the Local Authority coordinated admissions scheme, be considered by **!the**al Governing Bodynd the parents advised of theutcome.

If the request is agreed and the year group for which the parents have requested a place is a current year group in the school, then the application will be considered by Ltbe Governing Bodynd the parents advised of the outcome.

If the request is agreed and the year group for which the parents have requested a place is for a future year group, ie Reception in Septemb2025, then the original application is withdrawn and the parents must submit a fresh application for Recepti2025 when applications open in the autumn term 2024. Please note that parents only have the right to apply for a place. Where theocal Governing Bodgrees to consider an application for Reception the following year, that application is considered alongside all other applications received and parents will be advised of the outcome of that application on national offer day. No place is reserved or helfor the child in advance.

You are encouraged to ensure that your application is received on time.

#### CHANGE IN PREFERENCE

Once parents have submitted their preference, they will not be allowed to change them without an exceptional change in their circumstances, for example, if the family has recently moved address or an older sibling has changed schools. All requests to generate ferences should be made in writing to the Local Authority to whom the parents submitted the original application. Where a change of preference is submitted for an oversubscribed school, without an exceptional change in circumstances, then the application will be refused.

#### WAITING LIST

In addition to their right to appeal, children who have not been offered a placeat ady of Mount Carmel but were offered a school that was ranked as a lower preference on their application form will be added to a waiting list. The waiting list will be maintained until the last day of the summer t2025 and will then be discarded.

Children who are the subject of a direction by the Local Authority to admit or who are allocated to a school in acordance with the Fair Access Protocol take precedence over those on a waiting list.
